

## **Terms and Conditions for Scholarship Recipients**

### **Eligibility Requirements:**

- The student must achieve at least 80% in their academic marks.
- The student must be enrolled in an accredited Government or Government-Aided institution.
- The student must demonstrate financial need.

### **Application Process:**

- The student must undergo the selection process fairly.
- The student must provide all required documentation, including marksheets, proof of enrollment, fee structure, and receipts for any other relevant training programs.

### **Scholarship Amount and Disbursement:**

- The scholarship amount will be determined based on the student's needs.
- Funds will be disbursed directly to the educational institution or as specified by VRCF.
- Disbursements will be made in installments (e.g., per semester or annually as required).

### **Use of Funds:**

- Scholarship funds must be used solely for educational expenses, including tuition, fees, books, supplies, and hostel fees.
- Any misuse of funds will result in the termination of the scholarship and potential reimbursement of the disbursed amount.

### **Reporting and Communication:**

- The student must provide periodic reports on academic progress and any changes in financial status.
- The student must promptly inform the foundation of any changes in contact information or enrollment status.

### **Conduct and Compliance:**

- The student must adhere to the code of conduct and policies of their educational institution.
